**Course Overview:**

The goal of Economics 5360 is to introduce economics majors to the field of industrial organization (“I.O.”). I.O. is also often referred to as “antitrust economics.” Its focus is the study of various forms of competition, monopoly, and their welfare implications.

**Course Objectives:**

In this course you will learn the basic economic models studied in industrial organization. You will be expected to have a working understanding of Calculus. Once we have covered the basic economic models, we will study how these models are applied in antitrust and regulatory contexts by practicing economists.

**Teaching and Learning Methods:**

The course will use a combination of traditional lecture, active group reading and presentations, and interactive learning via Canvas.

**Required Text:**

No required text. The readings are posted in Canvas.

**Course Requirements:**

Midterm exam worth 40%; final exam worth 40%; in-class presentations worth 20%. Grading will be on a class curve.
