Exams

There will be one mid-term exam and a final. The mid-term exam will be held on **6/18/2013** and the final will be a take-home exam, the due date for which will be announced. The exams will include a mixture of short-answer questions, quantitative problems, and one or two essay questions. Each of the exams (including the final) will be worth 20% of your grade. You are expected to be in class to take the exams on the given dates. If you anticipate any unavoidable scheduling conflict, please contact me immediately. Exams may be rescheduled only with express written permission provided in advance. Assigned readings from the text, additional required readings and topics discussed in class will be represented on the exams.

Reaction Papers

You will be required to write three (3) Reaction Papers due **5/25/2014**, **6/8/2014** and **6/22/2014** through the Canvas assignment submission function. These papers should be used to assist you in building the content for your research project. For *each paper* you are required to find two or more published journal articles specifically associated with your research topic, discuss them relative to your research topic, offer your personal reaction to the authors’ arguments, methods and conclusions and present economic models illustrative of the concepts being addressed. These papers are to be no less than 750 words in length, must include appropriate economic graphic representation of the issue being addressed and will be graded on content, grammar, syntax and proper use of graphs and charts. It is important to note that economic graphics (models) are not simply charts, tables or graphs presenting values associated with the issue, but are specifically formatted graphs designed to present economic models with their temporal or equational dynamics.

An excellent Reaction Paper (one that receives 80%+) addresses a timely topic, points out strengths and weaknesses of the author(s) argument(s), includes at least one economic graphic representing the dynamics or effects of the issue being addressed, and offers your personal opinion, or reaction, in respect to the issue. Examples of excellent Reaction Papers can be found in Canvas.

Research Projects

At the beginning of the term you will be assigned to work on a research project with 1-3 other students, with each topic being specific to one of the various concepts addressed in this course. Your project will culminate in the formation of a short presentation and research poster to be presented in the Economics Department on **Thursday, July 31st** and will be considered for inclusion in the CSBS Student Research Day competition to be held April 2015.

These projects should display the assigned topic using contemporary and relevant data, examples, methods, and models in such a way as to highlight the issues associated with the topic as they relate to concepts addressed in the course. Presentations and posters will be judged by a select group of professors and graduate students from the Economics Department, with the scores associated with the adjudication heavily influencing your overall score for the assignment. This set of assignments and adjudication score will comprise 15% of your grade for the course and are due as follows:

Focus Presentations The groups assigned for the research projects will be required to prepare and present a Focus Presentation based on the assigned topic during the course. During the second week of class dates will be assigned as research topics are selected. The Focus Presentation is designed to give you the opportunity to consider the assigned topic and discuss it with the class in such a way as to enhance your understanding of the topic as well as that of the class. The presentation should include appropriate media; questions and answers time is in addition to the 15-20 minute presentation. These presentations will begin with the 3rd week of class and run through the end of the semester.

Graduate Student Policy Paper Graduate students enrolled in Econ 6190 will be required to write a policy paper due **August 3, 2014**. This paper should discuss a particular element of economic policy as it relates to the research project topic the student is assigned and should evidence the student's understanding of the economics of health and healthcare. The paper should be between 1,500 – 2,000 words, include references and citations to no less than eight (8) published sources, and include appropriate graphs and tables.

Class Participation This course is designed to be highly participative and participation in class discussions may be the source of meaningful extra credit. We will take time during most classes to discuss current domestic and international health economic issues. **There will be material covered in class that will not be part of the reading or assignments, but for which students will be responsible on Mid-Term and/or Final exams.**
