Course Description

This course explains the basic concepts of Microeconomics that cover consumer and producer theory and how these two interact in markets. Students will understand the choices that consumers and producers make and how these choices are influenced. This course will address questions including what goods and services will be produced, how production takes place and who gets the goods and services.

Course Outcomes

1. Students will understand how the economy works to allocate resources.

2. Students will be able to use the concept of marginal analysis to evaluate how consumer and producer make a decision.

3. Students will be able to model the economic system and apply modern analytical techniques.

4. Students will be able to develop the critical thinking skills of an economist.

5. Students will be able to link the theoretical framework to current economic issues and future economics courses.
