# Work in Knowledge Networking, Knowledge Sharing and Capacity Development:

- Principal designer and co-organizer, coordinator as well as co-instructor of the 1. program on "Knowledge Networking on Engendering Macroeconomics and International Economics". This is a program that aims to enhance teaching, research and policy – making capacity internationally, especially in the global South on the gender, macroeconomics and international economics. The principal components of the program are preparation of self- study materials, an annual intensive summer course, an annual conference and the design of a website for knowledge sharing and capacity development. The Program started in May 2003 and has been repeated five times in 2003, 2004, 2005, 2006 at the University of Utah and in 2009 at the Levy Economics Institute in New York ) and 2011 in Istanbul at Istanbul Technical University. The program is located at the Department of Economics, University of Utah and can be viewed at www.genderandmacro.org. The network has various regional and thematic research groups to which I act as advisor). The program has been developed in Spanish by GEM-LAC (regional chapter of GEM-IWG) and repeated twice in Latin America (in 2006 in Mexico and in 2010 in Argentina). There is an Asia – Pacific version of the Program developed by GEM- Asia in collaboration with and housed in UNDP- Asia Pacific. This program was repeated twice in 2010 and in 2011. Overall more than 300 fellows (made up of academics, researchers and policy makers) from 70 countries have completed the program. The courses have been taught by teams of 20-25 internationally known economists. GEM-IWG has over 400 members, regional chapters and thematic research groups, as well as one country – level chapter, GEM – Turkey of which I am the founder.
- 2.
